



PROTOCOL TO AMEND THE ASEAN PLUS THREE EMERGENCY RICE RESERVE AGREEMENT

The Governments of Brunei Darussalam, the Kingdom of Cambodia, the Republic of Indonesia, the Lao People's Democratic Republic, Malaysia, the Republic of the Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand, and the Socialist Republic of Viet Nam, being members of the Association of Southeast Asian Nations (ASEAN) (hereinafter referred to collectively as "ASEAN Member States" or individually as "ASEAN Member State")

and

the Governments of the People's Republic of China, Japan and the Republic of Korea, being the Dialogue Partners of ASEAN (hereinafter referred to collectively as "Plus Three Countries" or individually as "Plus Three Country")

hereinafter referred to collectively as "ASEAN Plus Three Countries" or individually as "ASEAN Plus Three Country":

RECALLING the ASEAN Plus Three Emergency Rice Reserve (APTERR) Agreement signed on 7 October 2011 in Jakarta, Indonesia;

NOTING that the first five-year period (2013-2017) for annual contributions to the operational cost of APTERR set out in Attachment 2 to the APTERR Agreement expired in 2017;

DESIRING to extend the annual contributions to the operational cost of APTERR for further five-year periods; and

REFERRING to Paragraph 5 and Paragraph 6 of Article X of the APTERR Agreement, which provides for amendments of the APTERR Agreement;

HAVE AGREED as follows:

Article 1

Attachment 2 to the APTERR Agreement shall be replaced by a new Attachment 2, as set out in Annex 1 to this Protocol.

Article 2


This Protocol shall enter into force on the thirtieth day after the date of deposit with the Depositary of instruments of ratification, acceptance or approval by all APTERR Parties.

IN WITNESS WHEREOF, the undersigned, being duly authorised by their respective Governments, have signed this Protocol.


